ALLOCATION MEETING APRIL 18, 2016

The meeting was called to order by the Clerk, Jennifer Lorenz. After the Pledge of Allegiance, the following members responded to roll call: Paul Lehto, Kathleen Beattie, Timothy Palosaari, George Stockero, Michael Lahti, and Glenn Anderson. Also present was Jason Auel from CCISD.

The first order of business was to elect a chairman. Paul Lehto nominated Glenn Anderson. The nomination was seconded by Tim Palosaari. The Clerk called for any other nominations. There being no further nominations, a motion by Kathleen Beattie, seconded by Paul Lehto to close nominations and the clerk to cast one unanimous vote for Glenn Anderson. The motion carried by a voice vote. Ayes 6, Nays 0.

The meeting was turned over to Chairman, Glenn Anderson.

A discussion followed regarding the Fixed Allocation of 8 mills and how it is divided between the County, Townships and Intermediate School District.

A motion was made by Michael Lahti and seconded by Kathleen Beattie to divide the (8) mills as prior years. Houghton County 6.3, Townships 1.3, and Intermediate School District 0.4, and the renewal of the allocation of operating millage for the period of 2017 through 2020 inclusive. The motion included to put the issue on the August 2, 2016 ballot. The motion carried by a voice vote. Aves 6, Nays 0.

A motion was made by Paul Lehto to dispense with asking for budgets from the townships. The motion was seconded by Michael Lahti. The motion carried by a voice vote. Ayes 6, Nays 0.
