## HOUGHTON COUNTY BOARD OF COMMISSIONERS REGULAR MEETING/PUBLIC HEARING JUNE 15, 2021

The Houghton County Board of Commissioners held a Regular meeting/Public hearing on Tuesday, June 15, 2021, in the 5<sup>th</sup> Floor Conference room of the Courthouse, City of Houghton. The public was attending by Zoom and in person.

Call to Order:

The meeting was called to order by Chairman Albert Koskela at 5:00 p.m.

Pledge of Allegiance:

The Pledge of Allegiance was led by Chairman Koskela.

Roll call:

Approval of Minutes:

Chairman Koskela stated there was a correction on Page 4, and it should say Army Corps of Engineers, not Amy Corps of Engineers.

## 1. Standing committee

Commissioner Tikkanen reported to the Board on the following:

Solid Waste Committee: Single stream drop off for recycling on Tuesday, Wednesday, and Thursdays. 2 full tons have been recycled. He thanked the staff and the Copper Country Recycling Initiative for their hard work.

Commissioner Anderson reported to the Board on the following:

Agreed to move future Commissioner meetings to Circuit Court.

Expressed sympathy for the passing of Debbie Bradford. He thanked Senator McBroom for his hard work in the House Bill passing the Senate on changing the Commissioners terms to 4 year terms effective in the election year 2024. He stated a 5<sup>th</sup> company has acquired purchasing UPPCO.

Commissioner Janssen reported to the Board on the following:

Health Department: The Board toured a new lab that had Covid machines. This is the only lab like this in the Western U.P. Community health needs assessments, and those should be coming soon. Covid cases are low, and about 60% have received their second dose of the vaccine. Campground and fair fees have been approved to be waived for this upcoming year.

UPEDA: She watched a presentation on the work place future.

Commissioner Britz reported to the Board on the following:

He had a meeting with Pastor Aaron from St. Peter and Paul Church, regarding the Sharon Avenue property. Pastor Aaron requested the trees be left between the properties, and stated the Pastor was positive about the change in properties.

Chairman Koskela had nothing to report to the Board.

#### 2. Special Committee

#### 3. County Officers

Dennis Hext, Airport Manager, addressed the Board regarding the Airport. He stated they are having several inspections, and are at a 50% load factor. There is a rental car shortage nationwide. The T hanger is complete and full.

Todd LaRoux, Building Inspector, addressed the Board regarding the Building Department. He stated there have been 35 new homes built this year, and 140 building permits have been issued.

Kate Beer, Health Department, addressed the Board regarding Covid. She stated the numbers are down in Houghton County. There was another Covid death on Tuesday. They are working with the schools to develop a plan for the fall. Vaccines are still available for the public.

#### Old Business:

1. Election Results Concerns – Senator Ed McBroom via Zoom

Senator McBroom stated his report should be released in the next week on their Committee's investigation of the November 2020 election.

Commissioner Anderson asked about the numbers changing in Houghton County.

Senator McBroom stated Antrim County's numbers are explainable. He stated the tabulator tapes and hand count verified their numbers to be accurate. He further stated that the videos have been made up. He discussed the audits, and risk limit audits that were done after the election that confirm the tabulator tapes again to be accurate.

Commissioner Tikkanen questioned the videos and asked if the switching of the numbers was not true in Houghton County. Senator McBroom replied that the video is not true.

Ben Larson, Administrator, thanked Senator McBroom for his work on the Trails in Houghton County, and for him and other Congressmen and Senators coming to Houghton County.
