1. Standing committee

Commissioner Tikkanen reported to the Board on the following:

Recreation Authority: There were not enough Board members for a quorum. They will be drafting a letter to the DNR and copying legislatures within one (1) week asking for an action plan for the construction plans for the trails.

Solid Waste Committee: There will be a single-stream recycling drop-off point will be available to County residents starting April 29 on Earth Day at the Transfer Station. There will be a contract with Waste Management. The cost will be \$5.00 per vehicle. They will be working with the Copper Country Recycling Initiative. This is the first step for recycling at the Transfer Station.

Old Transfer Station Building: Great American Disposal is close to closing the transaction for the purchase of the building.

Commissioner Tikkanen encouraged the other Commissioners to read the email from March 31st from Homeland Security about safeguarding the systems as much as possible. Discussed Senator McBroom being on the Fraud Investigation Committee in Lansing, and maybe he could update the County.

Commissioner Anderson reported to the Board on the following:

Michigan Redistricting/Apportionment Commission: A public hearing will be held in Marquette. This is the only meeting in the Upper Peninsula. He asked the County Clerk who is on the local Apportionment Commission. Jennifer Kelly stated the members are herself, Lisa Mattila, Brittany Bulleit, and the Republican and Democrat Chairs.

Western UP Health Department: As of March 22nd, approximately 70% of elderly have been vaccinated. Approximately 36% of ages 16 and up have had their first dose, and about 61% of ages 49 and up and have their first dose.

RESOLUTION #21-04 HOUGHTON COUNTY PASSENGER FACILITY CHARGE FUND RESOLUTION TO REDUCE UNRESTRICTED NET ASSET BALANCE

WHEREAS, the Houghton County Passenger Facility Charge Fund has a deficit balance of unrestricted net assets as of September 30, 2020; and

WHEREAS, pursuant to MCL 141.921, any local unit of government ending its fiscal year with a deficit net asset balance must file a deficit elimination plan with the Michigan Department of Treasury; and

WHEREAS, failure to submit a deficit elimination plan and receive Department of Treasury approval for such plan could result in a reduction of State revenue Sharing; and

WHEREAS, the timing of PFC monies are collected and expensed, as directed by the Federal Aviation Administration, dictate that the Fund will always have a deficit balance of unrestricted net assets; and

WHEREAS, the activity currently being posted to the PFC Fund was previously reported in the Airport Fund but was split out for internal accounting purposes only; and

WHEREAS, the resulting deficit balance in unrestricted net assets is an internal accounting number only.

NOW, THEREFORE BE IT RESOLVED that the Houghton County Board of Commissioners recognize that the PFC Fund will be in a perpetual state of deficit balance.

BE IT FURTHER RESOLVED that the Houghton County Board of Commissioners approve the projected budget for the years ending September 30, 2021, 2022, 2023, 2024 and 2025 for the Houghton County Passenger Facility Charge Fund.

Sale of Lots 19 and 20 in the Houghton County Industrial Airpark, Revision of Resolution #21-02

WHEREAS, The Houghton County Board of Commissioners, as successor in interest to the dissolved Houghton County Airport Authority on July 24, 1989 is authorized to all rights of interest and statutory authority granted to the dissolved Houghton County Airport Authority.

WHEREAS, the Houghton County Memorial Airport Committee, created on July 26, 1989, under the Authority of the Houghton County Board of Commissioners, pursuant to Act 73 of the Public Acts of 1970 and Act 327 of the Public Acts of 1945, and pursuant to the authority vested in the County of Houghton by the Aeronautics Code of the State of Michigan has the authority to adopt rules and regulations for the management, government and the use of said airport property.

WHEREAS, on February 9, 2021, at a Regular Houghton County Board of Commissioners Meeting, Resolution #21-02 was adopted to approve the conditions set forth in the Purchase Agreement presented on January 11, 2021 with final acceptance on February 9, 2021 by Copper Island Academy for Lots 19 and 20 of Houghton County Airpark Plat, for the purchase price of \$50,000 pursuant to the Airport Industrial Park Covenants, Section 5, Resale Rights, recorded September 12, 1973, in Liber 23 of Misc. Records, Page 157, Houghton County Register of Deeds Records.

WHEREAS, Resolution #21-02 should also have authorized the sale of the northerly portion of a private road designated as Industrial Drive North located directly between Lots 19 and 20 of Houghton County Airpark Plat, along with Lots 19 and 20, all for the agreed purchase price of \$50,000.

NOW THEREFORE, BE IT RESOLVED, Albert Koskela, Houghton County Board Chairman, is authorized to sign the closing documents for the sale of Lots 19, 20, and the northerly portion of a private road designated as Industrial Drive North, located directly between Lots 19 and 20 of Houghton County Airpark Plat, to Copper Island Academy Real Estate, LLC, a Michigan limited liability company.

BE IT FURTHER RESOLVED, at a Regular Houghton County Board of Commissioners Meeting held on April 13, 2021, a resolution was adopted to

approve the conditions set forth in purchase agreement amendments, reconfirming the agreement to sell Lots 19 and 20 of the Houghton County Airpark Plat, and also specifically including the northerly portion of Industrial Drive North located directly between Lots 19 and 20, all for the original purchase price of \$50,000.00. This Resolution expressly acknowledges that all parties have waived any contingency regarding abandonment or vacation of any dedicated rights affecting the northerly portion of Industrial Drive North, and that the conveyance shall be subject to any and all restrictions, reservations, easements, rights-of-way, and covenants, including Section 5, Resale Rights, contained within the Houghton County Airpark Plat, September 12, 1973, in Liber 23 of Miscellaneous Records, Page 157, Houghton County Register of Deeds Records.

RESOLUTION SUPPORTING PASSAGE OF LEGISLATION TO ADOPT 4-YEAR TERMS FOR COUNTY COMMISSIONERS

WHEREAS, THE 1963 Michigan Constitution stipulation four-year terms for the county Board of Supervisors, the preceding body to today's Board of Commissioners; and

WHEREAS, the Legislature voted in 1966 to abolish Boards of Supervisors and formally replace them with Boards of Commissioners after the 1968 elections; and

WHEREAS, Public Act 261 of 1966 promulgated that the length of terms for the new County Commissioners shall be concurrent with that of state representatives, as specified in Article IV, Section 3 of the Michigan Constitution; and

WHEREAS, the scope of duties of a County Commissioner has greatly increased in the last century—road patrols, indigent defense, mental health treatment and substance abuse prevention programming, solid waste pick-up and disposal, food and water supply safety, park operations, economic development efforts, emergency management and response; and

WHEREAS, Michigan is one of only five states in the United States that provides for exclusively two-year terms for County Commissioners; and

WHEREAS, all other County and Township elected officials in Michigan are elected to terms of at least four years; and

WHEREAS, legislation to amend state law to enact four-year terms has been filed in the form of Senate Bills 242 and 245; and

WHEREAS, the Michigan Association of Counties supports the legislation as introduced;

NOW, THEREFORE BE IT RESOLVED, that the Houghton County Board of Commissioners support Senate Bills 242 and 245 to enact four-year terms for County Commissioners.
