VI. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Plumbing work shall not be started until the application for permit has been filed with the Houghton County Building Department. All installations shall be in conformance with the Plumbing Code. **No work shall be concealed until it has been inspected.** When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the job location and permit number. A New home requires three inspections, Underground, Rough-In and Final.

VII. Mobile Home unit

ITEM #2, MOBILE HOME UNIT SITE: When item is used for sewer excavation in a new park, the permit application must include the application fee plus the number of sites. When setting a HUD mobile home in a park, a permit must include the application fee, a sewer or building drain and a water service or water distribution pipe.

VIII. PLAN REVIEW REQUIRED

Plans must be submitted with this application and the appropriate fee before a permit can be issued, except as listed below: *Plans are not required for the following:*

1. When the building is not over 3,500 square feet in area.
2. Alterations and repair work determined to be of a minor nature by the plumbing inspector;
3. Work completed by a Governmental Subdivision or State Agency costing less than \$15,000.00;
4. Assembly, business, merchantile and storage building with a required plumbing fixture count of less than 12.

Plans which are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended, and shall bear the architect's or engineer's signature and seal.

IX. APPLICANT / HOME OWNER SIGNATURE

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL 125.1523A, as amended by 1999 PA 245, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential structure. EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND/OR CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION.**
