#### HOUGHTON COUNTY BOARD OF COMMISSIONERS PUBLIC HEARING & REGULAR MEETING JUNE 18, 2024

The Houghton County Board of Commissioners held a Public Hearing & Regular Meeting on Tuesday, June 18, 2023 at 5:00 p.m. in the 5<sup>th</sup> Floor Conference Room of the Courthouse, City of Houghton with the public viewing in person and by Microsoft Teams.

#### Call to Order:

The meeting was called to order by Chairman Tikkanen at 5:00 p.m.

#### Pledge of Allegiance:

The Pledge of Allegiance was led by Chairman Tikkanen.

#### **Roll Call:**

The following Commissioners responded to roll call done by Jennifer Kelly, County Clerk:

Tom Tikkanen, District 1; Joel Keranen, District 2; Glenn Anderson, District 3; Gretchen Janssen, District 4; Roy Britz, District 5.

#### **Approval of Minutes May 15, 2024 Regular Meeting:**

A Motion was made by Commissioner Janssen and seconded by Commissioner Britz to approve the minutes of the May 15, 2024 meeting as presented.

The Motion carried by a voice vote. Ayes 5, Nays 0.

#### **Approval of Agenda:**

Commissioner Anderson requested adding #8a to discuss a \$250,000 grant for a flight next summer.

A Motion was made by Commissioner Keranen and seconded by Commissioner Janssen to accept the Agenda as presented with the one (1) addition.

#### **Public Hearing-Truth in Taxation**

#### a. Open Hearing

A Motion was made by Commissioner Keranen and seconded by Commissioner Anderson to open the hearing.

#### b. Discussion and Public Comment

Elizabeth Anderson, Equalization Specialist, explained the Truth in Taxation hearing in order to collect the maximum millage rate of 6.2070 mills for the 2024 levy.

The Millage Reduction Fraction (MRF) is 0.9976 The Base Tax Rate Fraction (BTRF) is 0.9492 The 2024 taxable value is 1,237,399,250

The Baste Tax Rate (after application of the BTRF) is 5.9059 After adjusting the Base Tax Rate by the estimated Convention/Facilities Tax of 188,449 The resulting Base Tax Rate is 5.9057 The difference between the Maximum allowable rate of 6.2070 & the adjusted Base Tax Rate of 5.9057 is 0.3013 mills.

If approved, that difference nets a 5.10% increase in operating revenue from last year or approximately \$372,828 beyond last year's levy.

Host Schmidt asked a question about the 0.3013.

#### c. Close Hearing

A Motion was made by Commissioner Keranen and seconded by Commissioner Anderson to close the hearing.

#### **Public Comments:**

Horst Schmidt addressed the Board regarding M#3 and asked if a new employee was going to be hired. Joe Battisfore stated it is to continue funding a staff member's current position that was created in 2019 through this grant. There are 2 fulltime and 1 part time positions at the Veteran's Office.

#### **Approval of Bills:**

#### **Standing Committee:**

Commissioner Janssen reported to the Board on the following:

Meals on Wheels: She toured the facility. New kitchen equipment was recently received. There are more than 300 people on a waiting list for services.

BHK: There is a new program called Meet Up & Eat up for anyone under 18 years old at the Barkell and Baraga locations. They were recently ranked 12<sup>th</sup> in the Nation for a letter writing campaign. They will celebrate a 50<sup>th</sup> Anniversary this year.

Commissioner Britz reported to the Board on the following:

Houghton County Road Commission: In a 2023 survey for road conditions, Houghton County ranked 28<sup>th</sup> in the State in terms of durability and access for roads. There were 3 of 10 counties in the State that were from the U.P.

Laird Township: He attended their monthly meeting. He distributed a brochure to the Board for Bay Ambulance. Voters will vote on a millage in August. Bay Ambulance compared current calls at 1040 compared to 195. Bay Ambulance meets Ontonagon folks to make transports to our County Airport and local hospitals when called upon.

Commissioner Anderson reported to the Board on the following:

Canal View: He stated the Canal View's Board minutes and Board members are now visible on the Houghton County website with a link and postings each time they meet.

Vet Fest: He attended the Vet Fest and commented on the large amount of Veterans and vendors and thanked and highlighted the work being done by Joe Battisfore and others.

MTU SmartZone: He discussed a \$1.25 million grant for the Houghton and Hancock School Districts and a \$1 million grant for 5 counties in the U.P. They hope to accelerate 5 local companies, and to consider a \$10 million prototyping center for developing businesses, and possibly look to the EDA for another \$25 million in grant funding.

WUPPDR: They received their 3<sup>rd</sup> Hope Housing grant for low income housing. They previously received \$600,00. On September 16<sup>th</sup> at 5:00 pm, WUPPDR will have their annual meeting at the Bonfire Restaurant. All Commissioners were invited. The Guest Speaker that evening will be the Calumet Electronics Group.

He attended the Copper Country Trail National Scenic Byway meeting. He reminded the Board that the declaration was given to our area back in 2005, and that we are one of just 3 in the State of Michigan.

Brownfield Authority: They approved a \$41,000 loan for L&Z Rentals to renovate the old Kirkish building across from the Downtowner. This will create some housing and move the Sky Sushi restaurant to more space.

Commissioner Keranen reported to the Board on the following:

He attended a meeting regarding the flood in Lake Linden.

District Court Treatment Court: There will be a graduation on Thursday, June 20<sup>th</sup>.

#### **County Officers:**

Dennis Hext, Airport Manager, stated the airplane load numbers are strong this month. They are out for bid for EAS as the current EAS contract is up on January 31, 2025. Commissioner Anderson asked him about the shortage of pilots, and Dennis said that with the Boeing struggles that there is an ample supply of younger pilots. Dennis talked about the new Airport Terminal project and work that is being done by Mead and Hunt. Our concept is with the FAA now for their consideration.

Josh Saaranen, Sheriff, stated there are currently 26 inmates, 1500 complaints. The Jail Project Committee had their first meeting. The 2<sup>nd</sup> meeting should be in the next week or so.

Curt Judson, Transfer Station Manager, stated they are up 500 tons from last year. Recycling is only on Wednesdays right now from 8:00 am-4:00 pm. He stated the loader and mini excavator are starting to show their age.

Jennifer Kelly, County Clerk, stated she participated in the Vet Fest and she attend the UP Commissioners Conference in Escanaba. She discussed Senator McBroom's comments on following other states and eliminating the City and Township Clerks from running elections and turning everything over to the County Clerk. The November millage deadlines are quickly approaching.

### 7. Traverse Engineering Recommendation for Property Transfer to Torch Lake Twp.
