

ALLOCATION MEETING
APRIL 20, 2020

The Houghton County Allocation Board held a meeting on Monday, April 20, 2020 by Zoom.

The meeting was called to order by the Clerk, Jennifer Kelly. The following members responded to roll call: Mary Sears, Albert Koskela, Lisa Mattila, George Stockero, Michael Lahti, and Eric Waara.

The first order of business was to elect a chairman. Lisa Mattila nominated Michael Lahti. The nomination was seconded by Eric Waara. There being no further nominations, the clerk cast one unanimous vote for Michael Lahti.

The Motion carried by a voice vote. Ayes 6, Nays 0.

The meeting was turned over to Chairman, Michael Lahti.

A Motion was made by Lisa Mattila and seconded by Mary Sears to divide the (8) mills as prior years. Houghton County 6.3, Townships 1.3, and Intermediate School District 0.4, and the renewal of the allocation of operating millage for the period of 2021 through 2024 inclusive.

The Motion carried by a voice vote. Ayes 6, Nays 0.

A Motion was made by Michael Lahti and seconded by Eric Waara to put the Allocation of Operating Millage for the 8.0 mills on the August 4, 2020 ballot.

The Motion carried by a voice vote. Ayes 6, Nays 0.

We, the undersigned members of the Houghton County Tax Allocation Board, in the County of Houghton, and State of Michigan, petition the County Board of Commissioners to place before the voters of this County the question of establishing a separate tax limitations millage rate for a period of 4 years (2021, 2022, 2023 and 2024 inclusive), for the County of Houghton and the Townships and Intermediate School District within the County, the aggregate of which shall not exceed 8 mills, as follows:

The ballot language for the August 4, 2020 election will be as follows:

**RENEWAL AND ALLOCATION OF OPERTING MILLAGE
WITHIN THE COUNTY OF HOUGHTON**

Shall a renewal of separate tax limitations be established for the period of 4 years (2021, 2022, 2023 and 2024 inclusive) for the County of Houghton and the Townships and Intermediate School District within the County, the aggregate of which shall not exceed 8.0 mills, as follows:
