HOUGHTON COUNTY BOARD OF COMMISSIONERS PUBLIC HEARINGS & REGULAR MEETING FEBRUARY 11, 2025

The Houghton County Board of Commissioners held two (2) Public Hearings & a Regular Meeting on Tuesday, February 11, 2025 at 4:00 p.m. in the 5th Floor Conference Room of the Courthouse, City of Houghton with the public viewing in person and by Microsoft Teams.

Call to Order:

The meeting was called to order by Chairman Tikkanen at 4:00 p.m.

Public Hearing-HCRLF Loan for Gabby's Guppies

A Motion was made by Commissioner Janssen and seconded by Commissioner Britz to open the meeting.

Sam Stonelake, Business Retention Specialist with KEDA, discussed the loan request from Gabby's Guppies, LLC for \$60,000 from the Houghton County RLF. It will be a loan for 43 childcare slots and will employ 10 people. It will be located in the old Hancock High School building This was approved by the Revolving Loan Fund Committee.

Jeff Kerklook from the DNR will be retiring.

Trails: The engineering is close to being done on the Freda grade trail. They will find funding. Chassell Township will be a non-motorized trail sponsor. The Bill Nichols Trail: there will be new decks and railings on the 3 bridges this summer. There may be some closures during this time.

The Twin Lake State Park will be closed this summer to update the bathrooms.

Houghton Douglas Falls: They started the parking lot last year and should be complete this year.

Commissioner Britz reported to the Board on the following:

HCRC: The December snow total was 72.3" and the January snow total was 99.3".

Sheriff Department: Will be discussed later in the agenda.

County Officers:

Christ VanArsdale, Emergency Measurers Director, he stated he has been assisting the Village of Laurium with finding things they need and looking into grant funding.

Sheriff Saaranen stated the Pigs N Heat game was a success. They raised \$15,000-16,000.

There are approximately 22 inmates, and have averaged in the 20's the past month.

He discussed the Law Board meeting. The Sheriff Department should be fully staffed soon. He may have 2 individuals to go to the Academy, but right now only 1 is for sure.

Todd LaRoux, Building Inspector, stated he will be doing a walk through with 2 contracts on Wednesday for the back up generator. He will also do a walk through at the Marina on February 19th for the ADA Bathrooms.

Teresa Hill, HR Manager, discussed the wage study. She is going over the job descriptions to make sure things match for the company that is doing the wage study.

Dennis Hext, Airport Manager, discussed the terminal. He applied for a 3rd flight grant and was approved. This will be for June, July and August. He applied for another 3rd flight grant for September and October 2025 and August 2026. He applied for a grant for 6 box hangers The Charter for Riverside has been sold out. He stated there were 730 flights last year and 31 were canceled. That is about 4% of flights which is a low percentage. They have about a 75.9% loading factor, with 53,050 passengers in 20024.

COMMUNITY DEVELOPMENT BLOCK GRANT LOAN PROGRAM (CLP) AUTHORIZING RESOLUTION #25-02

The following is a copy of a resolution adopted by the Houghton County Board of Trustees during the regular County Board Meeting held at 4:00 p.m. on Tuesday February 11, 2025, on the 5th floor of the Houghton County Courthouse, 401 East Houghton Avenue, Houghton, MI 49931.

WHEREAS, assisting the startup, expansion, or location of companies that create new jobs is a priority for Houghton County; and,

WHEREAS, the proposed Gabby's Guppies, LLC will assist the creation of new childcare jobs in the County; and,

WHEREAS, the Michigan Economic Development Corporation (MEDC) offers loans for assisting companies with working capital, machinery and equipment as well as building renovations; and

WHEREAS, Houghton County has requested Community Development Block Grant Loan Program funding authorization in the amount of \$60,000 from the MEDC; and,

WHEREAS, the proposed project is consistent with the local community development plan as described in the application and that at least 51% of the beneficiaries of the proposed project would be low and moderate income persons; and,

WHEREAS, no project costs will be incurred prior to a formal loan award, completion of the environmental review procedures and a formal, written authorization to incur costs is received from the MEDC.

THEREFORE, BE IT RESOLVED that the Houghton County Board of Commissioners authorizes submission of a CDBG Application in the amount of \$60,000 for Gabby's Guppies, LLC project.

FURTHER, BE IT RESOLVED that Lisa Mattila, County Treasurer, is authorized to execute the application form and attachments on behalf of the County, sign the Loan agreement, and serve as the certifying officer for the environmental review.
