#### HOUGHTON COUNTY BOARD OF COMMISSIONERS REGULAR MEETING & PUBLIC HEARING JUNE 10, 2025

The Houghton County Board of Commissioners held a Public Hearing & a Regular Meeting on Tuesday, June 10, 2025 at 3:00 p.m. in the 5<sup>th</sup> Floor Conference Room of the Courthouse, City of Houghton with the public viewing in person and by Microsoft Teams.

#### Call to Order:

The meeting was called to order by Chairman Tikkanen at 3:00 p.m.

#### Pledge of Allegiance:

The Pledge of Allegiance was led by Chairman Tikkanen.

#### **Roll Call:**

The following Commissioners responded to roll call done by the County Clerk, Jennifer Kelly:

#### Approval of Minutes: May 13, 2025 Regular Meeting, May 29, 2025 Special Meeting

A Motion was made by Commissioner Anderosn and seconded by Commissioner Janssen to approve the minutes of the May 13<sup>th</sup> and May 29<sup>th</sup> Meetings as presented.

#### a. Open Hearing

#### b. Discussion and Public Comment

Jaikob Djerf, Equalization Director, stated that Houghton County is required to hold a Truth in Taxation Hearing in order to collect the maximum allowable millage rate of 6.2464 for the 2025 summer levy.

The Millage Reduction Fraction (MRF) is 0.9915

The Base Tax Rate Fraction (BTRF) is 0.9617

The 2025 taxable value is 1,318,823,506

The Base Tax Rate (after application of the BTRF) is 5.9692

After adjusting the Base Tax Rate by the estimated Convention/Facilities Tax revenue of 175,821

The resulting adjusted Base Tax Rate is 5.9690

The difference between the Maximum allowable rate of 6.2464 & the adjusted Base Tax Rate of 5.9690 is 0.2774 mills.

If approved, that difference nets a 4.65% increase in operating revenue beyond last year's base rate or approximately \$365,800 (841) beyond the base rate established with last year's levy.

#### c. Close Hearing

#### **Standing Committee:**

Commissioner Keranen reported to the Board on the following:

Wage Study. He referenced an email received from a Heather from Gallagher. They have submitted a proposal.

Commissioner Janssen reported to the Board on the following:

MSU Extension: There will be a Tall Ship coming to Houghton County in July. There will be family events.

Commissioner Anderson had nothing to report to the Board.

Commissioner Britz reported to the Board on the following:

HCRC: The April 2025 snow total was 329.8" in Painesdale compared to 154.9" last year.

Sheriff Department: He stated he met with Commissioner Keranen and the Sheriff. The new Houghton County Sheriff application will be coming soon for viewing inmates.

Chairman Tikkanen reported to the Board on the following:

Jail: He stated members of the community will form a citizens group with the Leage of Women Voters to raise hopefully \$10,000 in funds to promote support for the August jail millage.

Commissioner Anderson stated that the Democrat and Republican parties are supporting the jail.

#### **County Officers:**

Clerk Kelly stated each City and Township should prepare for new voting equipment in 2027. The cost will be approximately \$15,000 per precinct. As of right now, the Bureau of Elections stated the State does not have the money to put towards the new equipment like they did in 2017. The Cities and Townships will also be responsible for getting new equipment for the Early Voting Center.

Jaikob Djerf, Equalization Director, stated that the three (3) in the Equalization Department are doing assessing. The P60 audits have been favorable audits.

Todd LaRoux, Building Department Manager, stated the marina ceiling and door frames have been painted. The FRP board is a problem, and the new one hasn't arrived yet. It will need to be installed. The roof is 100% done. The new generator should be here in 4-5 weeks.

Nolan Miles, the new Houghton County Drain Commissioner, introduced himself to the Board.

Administrator Rheault introduced Alex who is the new Finance Manager.

Commissioner Janssen stated that she has reviewed 6 properties. Out of the 6 properties, 5 are land locked. She will meet with Jaikob Djerf about 1 of the properties and report back to the Board.

#### 3. Treatment Court SAMHSA Grant-Gail Ploe, WUPHD

Gail said the person could be a WUPHD employee.

Gail stated Jason Rota is the current part time employee of Houghton County for Treatment Court.

Commissioner Britz feels the employee should be a WUPHD employee.

Motion was made by Commissioner Anderson and seconded by Commissioner Janssen to authorize Cathryn Beer to be the new Signing/Business Official. The County and WUPHD will discuss who will be the supervisor for the new full-time position by the next Board meeting.

# URGING ACTION TO OPPOSE PROPOSED CUTS TO MEDICAID BY THE FEDERAL GOVERNMENT

#### Resolution # 25-08

**WHEREAS**, the Houghton County Board of Commissioners recognizes that Michigan's public mental health system is facing a serious and escalating funding crisis, driven by several compounding factors, including the loss of Medicaid-covered lives, inflationary pressures, increasing demand for services, and expanding regulatory burdens; and

**WHEREAS**, the Michigan public health system funding increases for core behavioral health and intellectual/development disability services have not kept pace with medical inflation and have in fact, recognized flat funding for the last five (5) years, while medical inflation has increased by over 10% and Medicaid expenses have increased by nearly 25%; and

**WHEREAS**, the State of Michigan has lost nearly 700,000 Medicaid beneficiaries since the end of the Public Health Emergency (PHE), resulting in reduced capitation payments to CMHSPs despite continued or increasing demand for mental health services; and

**WHEREAS**, the proposed cuts to Medicaid would force impossible choices including-shrinking access to care, shifting costs onto the State budget and to local providers and threatening the coverage of people with disabilities who require daily support; and

WHEREAS, additional factors exacerbating this crisis include skyrocketing inpatient psychiatric and residential costs, AND Misclassification of Medicaid eligibility groups resulting in lost revenue; and

**WHEREAS**, failure to adequately fund the public behavioral health system undermines the ability of CMHSPs and the State of Michigan to meet the needs of the most vulnerable residents-including children, adults with serious mental illness, individuals with intellectual and developmental disabilities, and those with substance use disorders.

**NOW, THEREFORE, BE IT RESOLVED**, that the Houghton County Board of Commissioners urgently calls on the United States Legislature, and the President to:

- 1. **Fully allocate Medicaid behavioral health funds to the State of Michigan** in fiscal year 2025 and beyond.
- 2. Forego propose reductions to Medicaid through; Shifting to block grants, Per Capita Caps, reducing Medicaid expansion, or other suggested means of reducing the federal share for Medicaid spending which would transfer the financial burden to the State of Michigan.

**BE IT FURTHER RESOLVED,** that copies of this Resolution be transmitted to local Senate and House of Representatives of the U.S. Legislature and the Michigan Association of Counties.
