The Houghton County RLF review committee at its January 29th meeting reviewed and is recommending approval of a \$60,000 working capital loan to Gabby's Guppies, LLC, a childcare center, located in Hancock Michigan and submitting the appropriate Community Development Block Grant (CDBG) Application to the Michigan Economic Development Corporation (MEDC). The loan will have an interest rate of 7% and be amortized over 10 years. The \$79,971.71 project is being supported with a \$19,971.00 grant from the SmartZone small business support hub grant program.

This project is a startup childcare center offering 46 desperately needed childcare slots. This project will create 10 new jobs.

If the County Board is in favor of making this loan, then the following approvals will be needed to comply with current MEDC guidelines for Houghton County's CDBG capitalized fund:

- 1. Approve the HCRLF committee's recommendation to make a \$60,000 M&E, working capital and building renovations loan to Gabby's Guppies, LLC under the terms and conditions approved by the Review Committee in their attached minutes.
- 2. Approve the attached Authorizing Resolution to submit the CDBG Application to the MEDC.


